### RESOLUTION FOR THE NAME CHANGE OF PS3K (75K053)

**WHEREAS**, the Citywide Council for District 75 (CCD75) is the duly authorized public body representing families of students with disabilities citywide and is responsible for advising and commenting on matters of significance affecting District 75 schools; and

**WHEREAS**, PS3K (District 75 program designation 75K053) is an existing school that has previously operated without an official school name, and the establishment of a formal name is necessary for identity, culture-building, and alignment with Chancellor's Regulation A-860; and

**WHEREAS**, the proposed name "**Dominick Della Rocca School for the Arts**" reflects the school's mission and vision to cultivate creativity, inclusion, and artistic development among District 75 students; and

**WHEREAS**, the Parent Association/Parent-Teacher Association of PS3K has been consulted in accordance with Chancellor's Regulation A-860, Attachment No. 1 and No. 3, and minutes of the PA/PTA meeting reflect discussion of and support for the proposed naming; and

**WHEREAS**, Superintendent **Dr. Keisha McCoy** has reviewed, endorsed, and signed the naming request, and Principal **Heather Leykam** has submitted the required documentation, demonstrating full administrative support; and

**WHEREAS**, the naming request complies with all required components of Chancellor's Regulation A-860, including consultation, documentation, and submission procedures;

**NOW, THEREFORE, BE IT RESOLVED**, that the **Citywide Council for District 75** hereby **approves and supports** the official naming of PS3K as:

**THE DOMINICK DELLA ROCCA SCHOOL FOR THE ARTS**

**BE IT FURTHER RESOLVED**, that this resolution shall be transmitted to the Division of Family and Community Engagement (FACE), the Office of Student Enrollment (OSE), the Superintendent, and the School Principal, to complete all requirements under Chancellor's Regulation A-860 for formal adoption and public posting.
