Challenges: Limited access to multiple languages for translation and interpretation due to fiscal conservatism.

Outcome: Denying language access, denies access to education, information, Communities that have been historically excluded and are on the margins continued to be excluded from many of our informational meetings due to interpretation limitations.

Proposed solution: The office of Interpretation and Translation can you utilize the data from the DOE regarding the number of non-English and Spanish speaking students and families that comprise to inform their decisions

Recommendations:

- *Safety committee members will utilize tracking system and continue to build resources
- *The Safety committee will continue to provide useful and tangible resources and information.
- *District 75 will work collaboratively with Citywide Council District 75. This will be accomplished by sharing data in a timely manner. In doing so, a shared expansion of knowledge and resources will emerge.

- *CCD75 will continue to work on establishing a working relationship with the Office of Safety and Youth Development to ensure that parents are involved in the decision making process and implementation of prospective initiatives and plans.
- *District 75 should rotate council members who sit on advisory boards in order to provide a broader perspective.i
- *District 75 will update parents regarding utilization of Project Pivot funds along with feedback and data after each semester
- *District 75 should provide public facing aggregated data and quantifiable data which includes but isn't limited to:
- -safety incidents in and around school campuses ,number of students and caregivers that are English language learners, dual language learners and the primary language of parents .
- -Specific language accompanied with the respective schools and residential districts of the students -

Provide data regarding implementation and outcomes of restorative justice programs.

- *Provide data regarding allocation of funds and implementation of project pivot program
- *Establish and/or improve relationships between Precinct Commanders and Principals with the objective of involving all D75 Principal in weekly Precinct meetings

Suggestions

Consider all 12 current disability classifications when designing and implementing all DOE systems and initiatives.

Include all relevant and impacted parties in the design and implementation of this new security lock system. Such parties may include supervisors and staff for HES and EVS, along with the hearing and visually impaired populations in order to guarantee accessibility for all.
