#### PRESIDENT'S REPORT: GLORIA CORSINO

The Chancellors is encouraging parent engagement and as a council we took an initiative to send to all of the parents an outreach letter (translated in various languages) we also created a pamphlet that will help parents navigate Special Education. The parent letter will help us without reach and increase our distribution list. We brought the council's parent letter and Navigating Special Education pamphlet to the meeting for you to fill out and return to us at the end of the meeting and share with your school community.

#### SUPERINTENDENT'S REPORT: GARY HECHT

Superintendent Gary Hecht mentioned the following:

-Opened a new program 469X 60 (school organization with three sites for turning 5 students).

-D 75 participated in Learning Partners this year. The Chancellor provided opportunities for schools to be involved with Learning Partners (D75 partnering with general education schools borough wide). D75 schools/programs are partnered with 94M, 176X, 168X and 231K; they will share expertise, strategies and best practices.

-Ms. Chase, Special Education Division is no longer with the Department of Education. Ms. Chase's replacement is Christina Foti, Principal of 231K (D75). Her school has great practices in place, is a well-developed school and it was a great choice because of her knowledge and expertise with D75.

-Ms. Foti replacement is Jude Arthur, Inter-Acting Principal who was previously at 224Q and is scheduled to go through the C30 Process.

-Middle School after- school program started yesterday. OPT was vocal and helpful in ensuring that our students received busing. The district received 7 million for the after- school program and 2 million for busing.
