#### **Resolution #7 To Declare a Seat Vacant**

**WHEREAS**, NYS Ed. Law, Art. 52-A, § 2590 and the Regulation of the Chancellor D-150 provides that a member of a community, citywide, district education council who refuses or neglects to attend three meetings of such council of which he or she is duly notified, without rendering in writing a good and valid excuse therefore vacates his or her office by refusal to serve; and

**WHEREAS**, the law further provides that, after the third unexcused absence the community, citywide council shall declare a vacancy to the chancellor; and
