2. Interview Applicants for Vacancy Seats on the Council

Mr. Williams called to order the names of candidates to fill a vacancy: Gloria Corsino, 6-yes, and Jackie Pierre-Louis, 6-yes All were in favor to accept the candidates to the council and a resolution will be presented and read at the next calendar meeting.

3. Update: Related Service

Mr. Williams informed the council parents in Staten Island are calling him regarding their concerns about related services. He has been conveying parents concerns to Mr. Hecht, Superintendent of district 75. Mr. Williams also informed the council that he has reached out to a few people within the DOE to attend and they declined his invitation due to prior commitments. Also he was invited to attend a meeting on behalf of the parents in Staten Island to further discuss the topic. A suggestion was made to have a person on the council to focus on Related Service and report back to the council periodically. Aliya Rasool agreed to be the related service representative for the council.

4. New Regulations: School Lunch Program for District 75

The council; discussed there is a new pilot program all children in D75 schools automatically eligible to receive free lunch. Parents will not have to go on line to register or fill out the lunch applications. Gloria Smith mentioned to the council that students are no longer provided choices when it comes to their lunch. Children are being served one selection during their lunch period. The council decided that two council members should serve on the lunch committee and meet with the DOE school lunch program supervisors. Gloria Smith and Charlene Carroll—Hall council members will work on the issue report back to the council at the nest working meeting. The council will decide to format a resolution to support their findings.
